

RESIDENTIAL REFERENCES – Oakland County

Butler Ridge Subdivision (West of Adams / South of Avon)

- **3629 Piccadilly Drive (2007)** – Complete landscape design and development of front and backyards, brick paver entrance, retaining walls and steps, masonry brick walls, circle drive, gunnite pool with hot tub, fireplace and outdoor kitchen area. Stamped concrete pool deck and landscape lighting of entire yard.
- **3790 Piccadilly Drive (2006)** – Complete landscape design and development of front yard, formal brick paver entrance, fountain, masonry columns and limestone balustrades, and landscape lighting.
(2015) - Complete landscape design and development of backyard to include Gunnite pool with hot tub, brick paver pool deck with retaining walls and steps.

- **1707 Lincolnshire Drive (2013)** - Complete landscape design and development of front and backyard, brick paver entrance with masonry columns and retaining walls, SienaStone steps, brick paver patio with keystone retaining wall, LED lighting.
- **1927 Lincolnshire Drive (2004)** – Complete landscape design and development of front yard and courtyard, brick paver entrance, landscape lighting and circle drive design. Includes brick and limestone balustrades. **(2018)** – Development of backyard landscape, LED lighting, brick paver patio, steps and retaining walls.
- **3545 Strathcona (2012/2013)** – Complete landscape design and development of front and backyard, circle drive, masonry columns, brick paver entrance, gunnite pool with hot tub, outdoor fireplace and pergola, brick paver pool deck and natural stone retaining walls and steps, LED landscape lighting of the entire yard.
- **3726 Thatcher (2012/2013)** - Complete landscape design and development of front and backyard, retaining wall, brick paver patio, walk, and LED lighting.
